Accordingly, the NCTE Hqrs issued a deficiency letter No.93-45/2014/NCTE/Insp/A86669 dated 01.05.2014.

In response to the deficiency letter issued by the NCTE Hqrs, the institution submitted its clarification vide letter dated 28.05.2014 to the ERC, NCTE, Bhubaneswar. The committee considered the report of NCTE Hqrs as well as representation submitted by the institution, the matter was discussed in detail and decided as under:


